- Application of ERS<sup>™</sup>400 two-component thixotropic epoxy resin on the area covered by the tackle with FCL<sup>™</sup> frp composite lock
- Installation of FCL<sup>™</sup> frp composite lock and mechanical tightening.
- Impregnation of the fabric of FCL<sup>™</sup> frp composite lock with ERS<sup>™</sup>200 two-component epoxy resin.
